## 1.0 DECLARATION OF OPENING/ANNOUNCEMENT OF VISITORS

The Mayor declared the meeting open, welcomed all those in attendance and conducted an Acknowledgement of Country.

## 2.0 PUBLIC QUESTION TIME/ADDRESS BY MEMBERS OF THE PUBLIC

Mr Don Yates, 10 Thompson Road, Success Hill

Mr Yates asked whether the Council is aware of the State Government's Development Control Policy 1.6 and whether it applies to the proposed development.

The Senior Planner responded that he does not believe it is relevant to the development.

The Manager Planning Services commented that it is a strategic policy document which was taken into consideration when the Town Planning Scheme was adopted in 2008.

## Mr Bill Dreyer, 31 Naunton Crescent, Eden Hill

Mr Dreyer asked why a Special Council Meeting was required to discuss this matter.

The Chief Executive Officer responded that Council is working within the timeframe set by the Development Assessment Panel (DAP) and the next Ordinary Council Meeting would be outside this timeframe.

#### 4.1 <u>Proposed 22 Multiple Dwellings - Lot 54; Nos. 72-74</u> <u>Railway Parade, Bassendean - Owners: Mark and Sandra</u> <u>Hammond, Applicant: Urban and Rural Perspectives(URP)</u> (Ref: DABC/BDVAPPS/2015-030 – Christian Buttle, Senior <u>Planning Officer</u>)

#### APPLICATION

At its Ordinary Council Meeting held in May 2011, Council resolved to require that all development assessment panel applications be subject to a report to Council in order that Council can make an alternative recommendation to the Metropolitan Centre Joint Development Assessment Panel.

The value of this proposal is \$3.3m, and the applicant has elected to have the application determined by a Development Assessment Panel (DAP).
