5.0 WORKSHOP TOPIC

5.1 Can you say bad things about people who have died?

The Youth Advisory Council discussed the morals around saying bad things about people who have died. The Youth Advisory Council felt that you shouldn't say negative or bad things about them immediately, but after some time it would be more acceptable.

When talking about someone who is a celebrity or people who have committed crimes, then the YAC felt that it was fine to say negative things about them immediately.

5.2 Changes to Late Night Trains

The Youth Advisory Council spoke about the proposed changes to the last night train services. The YAC felt that removing late night trains would result in more people drink driving. The YAC concluded that costs should not be a driver in the delivery of this type of service as the social costs could not be assessed.

5.3 <u>Metadata</u>

The YAC discussed the changes to metadata and how much privacy people willing to lose to protect the community from terrorism. The YAC felt that Federal Police should be able to use keywords to screen the internet for terrorism, but not conduct live surveillance, unless they have a good reason. It was also felt that the police shouldn't be able to prosecute people if they stumble across other offences unless they were looking specifically for them.
