I would like to take this opportunity to introduce myself to those of you that I have not yet had the chance to meet. I absolutely love living in Bassendean and enjoying all that our local area has to offer. As the mum of two young children, I feel extremely fortunate to be able to raise my family in the unique community and environment that characterises our Town. It is a privilege to serve as your new Mayor and to be part of making our Town an even more fantastic place.

Over recent months your Councillors and the Town's staff have been developing a budget that has a focus on our community's vision for Bassendean, strengthens our community and helps build a vibrant and more sustainable future. We are very conscious that your rates money should deliver projects and services that make Bassendean the place you want it to be. We have therefore based our budget on the feedback that you gave us through last year's community strategic planning process.

When formulating the budget for this year we were aware that for many people in our community finances are particularly tight at present. We were therefore determined to deliver a budget that reflected the current economic climate and have adopted the lowest rate rise in over a decade of just 0.9%, in line with CPI for WA. At the same time we have managed to include significant new projects while not affecting the service levels we currently enjoy. There has also been a focus on ensuring a more environmentally friendly budget. The Town is committed to showing leadership in this important area and has therefore allocated funds for the introduction of best practice kerbside waste management, almost tripling the number of street tree plantings, and providing an electric car charging station, as well as other sustainability initiatives.

Thanks to all of you for your contribution that allows us to deliver these projects and services over the next twelve months, and which will help make Bassendean an even better place.

The Town has managed to secure ~\$4 million in grant and reserve funding to deliver these projects and reduce the financial burden on our ratepayers. Safe Active Programs

State Government Charges:

what are they and how do they affect your rates?

Emergency Services Levy

This levy was introduced in 2003 to ensure that property owners were contributing to the provision of fire and emergency services in WA. This charge appears separately on your rates notice. It is collected by the Town and sent to the State Government. The State Government has increased this levy by 10.6% this financial year.

Waste Management Levy

This is a per tonne levy that the Town pays to the State Government for the disposal of waste at the Red Hill landfill site. Over the years, this levy has increased considerably. It directly affects the cost of the Town's waste management and therefore the rubbish service fee on your rates notice.

Rates Information

Rates Concessions Pensioners/Seniors

The State Government has approved a \$750 cap for local government rates applying to pensioner households as of 1 July 2018. Local governments are required by legislation to implement this policy change on behalf of the Government when they issue rates notices to affected pensioners.

This means that your local government rates notice now includes a concession that is the lesser of \$750 or 50% of rates payable. This cap applies only to the rate component of your account.

Senior cardholders' concessions remain unchanged at 25% up to a capped amount for 2018/2019 of \$100.

If you are the holder of a Pension Concession Card, Commonwealth Senior Health Card or a State Senior Card, and own and occupy your property at the 1 July 2018 and are not receiving a rebate, please contact Council's Office on 9377 8000.

Rebates to pensioners and seniors under the *Rates and Charges (Rebates and Deferments) Act 1992* are funded by the Government of Western Australia.

To receive the rebate on your 2018/2019 rates your account must be paid by 30 June 2019. Pensioners may defer their rates and Emergency Services Levy, but rubbish charges must be paid.

Paying by instalments

Pay in by two instalments:

- 1st instalment due 14 September 2018
- 2nd instalment due **18 January 2019**

Paying by four instalments:

- 1st instalment due 14 September 2018
- 2nd instalment due 16 November 2018
- 3rd instalment due **18 January 2019**
- 4th instalment due 22 March 2019
- Ratepayers must pay all outstanding rates, charges and accumulated interest by 14 September 2018 if they wish to participate in this scheme.

Fire Season

During the months of November to March, all properties within the Town of Bassendean must comply with Fire Season requirements. This means that owners must either slash or remove flammable materials to a height of no more than 100mm by 31 October and maintain this standard until 31 March 2019. Rangers will be inspecting the Town to ensure all properties comply.

Tip Vouchers

Your 4 tip vouchers are included as part of your rates notice.

To be eligible to receive vouchers you must be paying the \$365 waste service charge. Owners of vacant land will not receive tip vouchers, however vouchers will be issued to owners of new residences on a pro rata basis when interim rates are levied.

Please ensure you do not lose your tip vouchers as replacements will not be issued.
