## Bassendean town centre set for major transformation

A major plan to revitalise Bassendean is a step closer after key stakeholders signed a Heads of Agreement (HOA) to pursue the redevelopment of land around Bassendean Oval and the Town Centre. LandCorp, the Town of Bassendean and the Swan Districts Football Club have agreed to proceed with further developing plans to enhance and activate the existing Town Centre by delivering residential, commercial and employment opportunities for local residents close to existing infrastructure and public transport.

"This will create a residential and commercial heart for Bassendean and dramatically increase the number of people able to live in the Town, offering them a wide range of housing options," LandCorp Chief Executive Frank Marra said.

Mr Marra said there would be extensive community and stakeholder consultation as the plan progressed and businesses, community groups and residents would be encouraged to provide input into the planning process.

Town of Bassendean Mayor John Gangell said the redevelopment would significantly enhance the Bassendean Town Centre.

"This project will establish the Bassendean Town Centre as an iconic address and create a place where people will want to visit and live and enjoy a lifestyle that will be facilitated by a lively commercial district with restaurants and cafes all within walking distance of the train station."

"This work is an extension of past investigations and results from community consultation into delivering the vision and objectives of the Bassendean Town Centre strategy Plan.

"The vision included activating the eastern end of Old Perth Road and improving links to the train station. It will draw attention to the Town Centre and give Guildford Road motorists the feeling of driving through a special destination" Mayor Gangell said.

Swan Districts Football Club Chief Executive Officer Tom Bottrell highlighted the importance of the project progression from a community and financial perspective.

"The redevelopment will assist in ensuring the ongoing financial sustainability of the Swan Districts Football Club as an integral community sporting organisation in Bassendean".

#### **Reference group**

This signing of the HOA comes after more than a year of planning by a Stakeholder Reference Group comprising LandCorp, the Town of Bassendean, the Department of Planning, Swan Districts Football Club, the WA Football Commission, the Department of Sport and Recreation and the Department of Lands.

The project seeks to address state and local government policy to increase housing densities within an 800 m catchment of the Bassendean train station. It is also in line with the Government's *Directions 2031 and Beyond* strategy to cater for population growth and reduce urban sprawl.

#### 'Strong move forward ...'

Mr Marra said there is still a long way to go before the transformation can begin and State Government approvals need to be obtained, the formal partnership and agreement between LandCorp, the Council and the Football Club is a strong move forward.

Liaison with key stakeholders would take place to ensure mutually beneficial outcomes.

Located near the Swan River and along Guildford Road, the Bassendean Town Centre is close to railway stations, Perth Airport, schools, shops and family-friendly parks.

## Local Government Reform update



The State Government has broken its promise to fully fund Metropolitan Local Government Reform—the cost will be borne by ratepayers.

The Premier made a commitment, early in the reform process, to fully fund the cost of Metropolitan Local Government Reform (excluding capital costs) a cost estimated by the West Australian Local Government Association to be in the range of \$60 million to \$100 million.

The State Budget, handed down this month, demonstrates that this commitment will not be honoured. Indeed, the State is offering a total of \$15 million in grants over three years as direct support to local government reform and a total package of \$45 million dollars in loans to local governments to fund the balance of the reform process. These loans are required to be paid back by local governments within five years, and will need to be funded from the local governments' own resources. There is no guarantee that this will be sufficient for the purpose and there is no commitment to provide further funding if it is not enough.

## The Local Government Advisory Board will hand down its recommendations on Reform proposals in July 2014.

Whilst there is still some uncertainty in the recommendations that will go to the Minister from the Local Government Advisory Board, in any reform outcome there is no guarantee that the type of services and functions currently provided to our community will continue in any new, reformed entity.

The Town of Bassendean prides itself in maintaining a financially viable, efficient and effective Council to oversee the development and maintenance of community assets for the betterment of the Town as a whole.

There is still an enormous amount of work that needs to be done (by the proposed date of 1 July 2015) to complete the amalgamation proposals in order that the impact on the community is minimal. However, there has not been any clearly articulated financial or efficiency gains identified in any report by the State Government that would enable it to promote the Structural Reform as a benefit to the community or individual ratepayers.

#### The Town has urged the Board to recommend an amalgamation not a takeover so that Bassendean's interests are protected.

The Minister's (and the City of Bayswater's) proposal before the Local Government Advisory Board requests that there is a boundary adjustment between the City of Bayswater and the Town of Bassendean and incorporating areas of the Cities of Stirling and Swan.

The current proposal will see the Town of Bassendean being taken over by the City of Bayswater and the City of Bayswater's Council and Administration remaining in place. This proposal leaves the Town of Bassendean residents without a voice in the determination of functions and services for the new local government for around three months. The Town's elected Council would be dismissed on 30 June 2015, with only Bayswater's Council staying in place until the local government elections in October 2015.

The Town has since written to the Local Government Advisory Board advising them that the Town would only agree to **an amalgamation** of the two local governments (as well as the areas from the Cities of Stirling and Swan) as this would create a new local government in which the Town would be an equal partner in decision-making.

The Town has proposed an entirely new ward structure where Councillor Representation would be better distributed for the entire new area and a new culture would be created to enhance and provide good governance for the new local government. This is in response to the City of Bayswater resolving, without consultation, to base the ward structure for the new local government "principally on the City of Bayswater's current ward structure".

The Town has also urged the Board to consider the name "City of Bayswater–Bassendean" in recognition that a whole local government with a long history has been incorporated into the new entity.



# Sustainable gardens for seniors

Almost 18 months into the Sustainable Gardens Project and it continues to receive plenty of interest from the Town's seniors, with several projects on the go at present.

A recently completed project involved the replacement of a manual reticulation system with an automated water-wise system, which meant considerable saving on water bills. Drippers with three varying flow options were installed ensuring the plants get the right amount of water where they need it. West Australian native plants were selected for the site and existing soil was enriched with soil improver, soil wetter and native slow release fertilis<sup>o</sup>er. A thick layer of mulch was laid to protect the soil from weed germination and to assist with water retention. Plants are now flourishing and rewarding our client with some beautiful blooms and morning melodies from our nectar-loving native birds.

The Sustainable Gardens project is an initiative of the Town's Seniors & Disability Services' business unit and is available to eligible residents under the Home & Community Care program.

# Wind in the Willows volunteer program

Completed in mid-March, it is already proving to be popular with large numbers of users. The playground is located adjacent to Stan Moses Pavilion, off Robinson Road in Eden Hill.



## Sports lighting upgrade

The Town is currently upgrading the sports lighting at Jubilee Reserve. The upgrade has been achieved with the assistance of funding from the Department of Sport and Recreation via the Community Sport and Recreation Facilities Fund. The upgrade will provide Australian Standard training lights at Jubilee Reserve's AFL ground.

Council budgeted this financial year for the removal of the tennis courts and the small basketball court and some minor drainage and reticulations works in preparation for the major capital project in 2014–2015.
