6.3 Graduation Ceremony "Scholarship Award" donations to students of educational institutions located within the district, are limited to one per school per annum up to a maximum of \$250, and "Citizenship Award" donations limited to one per school per annum up to a maximum of \$50."

Reasons:

The intent of this dot point is clear in that any assistance which has a material benefit of greater than \$2k for the same event would make the applicant ineligible. Hire of equipment, facilities, traffic management and waiver of fees and charges for an event or activity would be covered by this addition.

Town of Bassendean award donations to individual students at school graduation ceremonies have tended to be generous often exceeding the average provided by other government agencies. The inclusion of Clause 6.3 provides guidance for the dollar amounts of scholarship award donations presented to individual students at school graduation ceremonies, bringing these in line with and similar to the award amounts offered to individuals via the Dudley Robinson Youth Award (clause 3.1).
