

# Councillor Training Register

Under section 5.126 (1) of the *Local Government Act 1995*, Council Members must complete Council Member Essentials training within 12 months of being elected to Council.

Under regulation 36 (2) of the *Local Government (Administration) Regulations 1996* a person who is a council member on the day on which the *Local Government Regulations Amendment (Induction and Training) Regulations 2019* regulation 8 comes into operation is exempt from the requirement in section 5.126(1) until the end of their term of office.

Under section 5.127 of the *Local Government Act 1995*, details of the training completed by Council Members for the previous financial year must be published on the Town's website.
