Opinion

We have audited the accompanying Statement of Comprehensive Income of the Town of Bassendean – "Wind in Willows" Child Care Centre for the financial year ended 30 June 2024, which is stamped for identification purposes.

In our opinion:

- The Statement of Comprehensive Income of the Town of Bassendean – "Wind in Willows" Child Care Centre has been properly drawn up so as to present a true and fair view of the operation of the project for the financial year ended 30 June 2024.

Basis for Opinion

The Statement of Comprehensive Income has been prepared to assist the management of Town of Bassendean to meet its reporting requirements to the Council. The Statement of Comprehensive Income may not be suitable for another purpose.
