

Council's longest serving councillor calls it a day

Anne Brinkworth, the Town's longest serving Councillor, has decided not to re-nominate for this year's local government elections after 26 years on Council.

First elected in May 1988, Anne served for six years before being defeated at the elections in 1994. She was re-elected in 1995 and has served continuously since then. Anne has been honoured with two Western Australian Local Government Association Awards for her services to Local Government—firstly in 2004 with a Meritorious Service Award and again in 2010 with a Distinguished Service Award. During her time on Council, Anne has served on numerous Committees, two highlights of which were the Australian Bicentennial Committee in 1988 and the Town of Bassendean's Centenary Committee in 2001.


Anne has always been passionate about community safety and seniors' interests. She has long been a supporter of initiatives such as Neighbourhood Watch and Safer WA.

One of Anne's greatest achievements was when she successfully lobbied to secure all-night street lighting within the Town of Bassendean when it wasn't standard practice. Anne believes this greatly improved safety for the Town's residents.



Anne is still an active Member of the Australian Red Cross and received the Association's 50 Year Volunteer Service Award in 2012.

Anne will be greatly missed by her fellow Councillors and the staff of the Town of Bassendean.



Bassendean Oval

The redevelopment of Bassendean Oval moved a step closer recently with the Town of Bassendean resolving to sign a Development Agreement with Landcorp and the Swan Districts Football Club.

The Town previously signed a Heads of Agreement to investigate the benefits and financial viability of a redevelopment of the Oval and the Development Agreement is the next step.

"There will be extensive community consultation on the redevelopment proposal," said Mayor John Gangell. "Over the next several months, every member of the community will be asked to provide feedback on the plan," he added.

2015/2016 Budget snapshot

In developing its current budget, Council has allocated funds to progress a number of exciting projects.

These include \$150,000 for the 'Men's Shed' proposal, which will allow the site to be prepared ready for construction. Funds have also been allocated to enable Council to submit an expression of interest application for underground power for the suburb of Bassendean. Also included are funds to progress the construction of a nature-based regional playground at Sandy Beach Reserve.

Funds have also been set aside for:

- Carbon Emission Reduction, Climate Change actions, Water Campaigns, School Waste Education Programs;
- Installation of Solar Panels to Council buildings and solar lights in the Robinson/ Broadway right of way;
- Community events and celebrations, and the publication of the last 40 years of the Town's history;
- Review of the Street Tree Plan, the Town Planning Scheme No 10, and the Municipal Heritage Inventory; and
- Roads and footpaths renewal programs.

Are you enrolled to vote?

Local Government elections will be held on Saturday 17 October 2015, so make sure you are enrolled to vote.

Australian citizens are automatically enrolled if they have voted in state or federal elections. If this is not the case, but you meet the eligibility criteria, an enrolment claim form should be made to the WA Electoral Commission by 5pm on Friday 28 August.

If you are not an Australian citizen, but are an owner or occupier of a rateable property in the Town, you may also be eligible to vote, provided you meet the enrolment criteria. A completed enrolment claim form should be lodged with the Chief Executive Officer by 5pm on Friday 28 August for assessment of your eligibility.



Would you like to represent your community?

Local Government elections will be held on Saturday 17 October 2015. So, if you believe you have what it takes to be a councillor, why not consider nominating? Becoming a councillor for your local government can be a highly rewarding experience.

If you enjoy dealing with people from all walks of life, like to be involved in decisions affecting your community, and are on the local government electoral roll, then consider nominating as a candidate in the upcoming local government elections.

To be eligible to nominate to stand as a councillor you must be over 18 years of age and be an elector of the Town of Bassendean. This includes all persons on the State and Federal electoral rolls and those owners and occupiers of property in the Town who are also registered on the Town's electoral roll.

Nominations open on Thursday 3 September and close at 4pm on Thursday 10 September 2015.



Those wishing to nominate can obtain a nomination form from:

- The Western Australian Electoral Commission; or
- Council's Customer Services Centre, 35 Old Perth Road, Bassendean.

Alternatively, you can download a nomination form from the State Electoral Commission's website at www.waec.wa.gov.au.

Owners and occupiers of businesses in the Town are eligible to vote and nominate to become a councillor if they enrol through Council to be on the roll.

Forms are available from Council's Customer Services Centre, or by contacting Ms Jane Goddard on 9377 8007.

It is important that your nomination and profile form, together with your deposit, are delivered to the Returning Officer before the close of nominations.

Voting system

The voting system will be first past the post and will require electors to place a tick against the candidates of their choice, up to and including the number of vacancies, which is for Bassendean a total of three ticks.

Proposed Crown Reserve Rationalisation

Lot 7557 Lord Street and 48 Chapman Street

At its meeting held on 23 June 2015, the Town of Bassendean resolved to consult the community and seek its views on a proposed closure of two Crown Reserves, Reserve 26529 and Reserve 31420, these being Lot 7557 Lord Street and 48 Chapman Street.

What is being proposed?

The Town of Bassendean is proposing to purchase the two reserves from the State Government for 5% of their value as assessed by the Valuer General's Office. If successful, Council is then proposing to sell the land (for residential purposes) and use the resulting funds for the establishment of a nature-based playground at Sandy Beach Reserve.

Why is this being proposed?

The two reserves in question are not fulfilling their intended purpose as public recreation reserves because of their size and location. The two reserves appear as standard residential blocks in residential streets.

Where will the money be spent?

It is proposed that the funds will be used to develop a regional playground at Sandy Beach Reserve. This site has been identified in the Town's Play Spaces Implementation Plan to build a large-scale playground. It is proposed that the playground will be a unique nature-based playground.

How long will all this take?

Depending on the response time from the State Government, the process in securing freehold title to the reserves, can take as long as 12 months.

Community views and support needed

For this project to move forward, the Town is required to consult with the community and gain their support on the acquisition of the reserves. Without clear support for the proposal, Council will not proceed.

Accordingly, Council is keen to seek the views of residents about the project. A letter will be circulated to all residents in the vicinity of the reserves, and an advertisement will be placed in the *Eastern Reporter*, on Notice Boards, in the Memorial Library, and on the Town's website

Rangers' Corner

Did you know that all dogs must be microchipped by 1 November 2015?

Microchipping is a permanent way of identifying a dog and is another way in which owners can record their details, so that if a dog gets picked up by the Rangers and it has lost its collar, we can still find the owner.

In November 2013, the State Government amended the *Dog Act* to provide that all dogs over the age of 3 months must be microchipped as well as being registered. The Act allowed that owners of currently registered dogs would have an amnesty period in which to get their dogs microchipped. This amnesty period is due to expire on 31 October 2015.

What does this mean for you?

If you are a dog owner and your dog is not microchipped, you will need to do this by 1 November 2015, regardless of when your registration period expires. You must also notify the Town of the microchip details.

Please note: penalties of \$200 apply for not microchipping your dog and also for not registering your dog.

If there is a medical reason as to why your dog should be exempt from microchipping, your vet will need to provide a certificate advising the Rangers of this.

Wendy also teaches Bhutanese weaving and plans to write a book about her experiences.
